B98.7 "POST MALONE / JELLY ROLL TEXT CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **B98.7 "POST MALONE / JELLY ROLL TEXT CONTEST" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
