B98.7 "POST MALONE ONLINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KBEE ("Station"), 434 Bearcat Drive Salt lake City, UT 84115, during available business hours Monday through Friday, on the Station website www.b987.com, or by sending a self-addressed, stamped envelope to the above address.

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
