B98.7'S "QUESTION IMPOSSIBLE" CONTEST OFFICIAL RULES

The Station will conduct the **B98.7's "QUESTION IMPOSSIBLE" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 90 Days and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 90 Days. Void where prohibited by law. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Contest Period. The Contest entry period will begin on or around 8:10am MT on January 6, 2025 and will run through January 10, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

On-Air: Listen to the Station weekdays during the Contest Period. When the Station asks the Question Impossible trivia question listeners must call the Station at 801-570-9870. Starting with caller #1 the station will take calls until the correct answer is given. Once the correct answer is received the caller will be deemed the winner and notified on that call. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
